3 ***Mandatory Training for ASUN Elected Officials***

5 **WHEREAS,** The Association of Students at the University of Nebraska-Lincoln  
6 (ASUN) serves to protect and be a safe space for the student body; and,  
7

8 **WHEREAS,** The Center for Advocacy, Response, and Education (CARE) offers the  
9 CARE 101 Sexual Assault Awareness training, designed to raise awareness and  
10 understanding of sexual assault cases on our campus, consent and healthy relationships,  
11 and resources available for students; and,  
12

13 **WHEREAS,** One in 5 women and one in 16 men are sexually assaulted while in  
14 college; and,  
15

16 **WHEREAS,** As student leaders, ASUN elected officials should go through this  
17 training to be informed leaders, promote a safer campus culture, and fulfill a responsibility  
18 to protect the student body and be an available resource for them; and,  
19

20 **THEREFORE BE IT ENACTED,** Elected officials will be required to attend a CARE 101  
21 Training on Oct 15<sup>th</sup> at 5:30 PM; and,

23 **BE IT FINALLY ENACTED,** If an elected official misses this training without prior  
24 notice they will be required to attend a makeup training set up by Sexual Misconduct  
25 Committee.
