<p align="center">Criminal Mischief / Destruction of Property (Neb. Rev. Stat. §28-519)</p>	<ul style="list-style-type: none"> - Less than \$500 damage: Class III Misdemeanor: Up to 3 months in jail and/or \$500 fine. - \$500 - \$1,500 damage: Class II Misdemeanor: Up to 6 months in jail and/or \$1,000 fine. - \$1,500 - \$5,000 damage: Class I Misdemeanor: Up to 1 year in jail and/or \$1,000 fine.
<p align="center">Disturbing the peace (Neb. Rev. Stat §28-1322) (LMC §9.20.050)</p>	<ul style="list-style-type: none"> - Class III Misdemeanor: Up to 3 months in jail and/or \$500 fine. - LMC: minimum \$150 up to \$500 fine and/or up to 3 months in jail.
<p align="center">Driving Under the Influence (DUI) (Neb. Rev. Stat. §60-6,196) (LMC §10.16.030)</p>	<p align="center">See DUI Chart</p>
<p align="center">Fraudulent / Altered Driver's License (Neb. Rev. Stat. §60-491) (LMC §§9.48.020/9.48.030)</p>	<p>Class III Misdemeanor: Up to 3 months in jail and/or \$500 fine.</p>
<p align="center">Leaving the Scene of a Non-Injury Accident (Neb. Rev. Stat. §60-696)</p>	<p>Class II Misdemeanor: Up to 6 months in jail and/or \$1,000 fine – up to 1 year license revocation.</p>
<p align="center">Maintaining Disorderly House (LMC §9.20.030)</p>	<ul style="list-style-type: none"> - 1st offense: \$250 - \$500 fine and/or up to 6 months in jail. - 2nd offense: \$350 - \$500 fine and/or up to 6 months in jail. - 3rd offense: \$400 - \$500 fine and/or minimum 3 days – up to 6 months in jail.
<p align="center">Minor in Possession of Alcohol (Neb. Rev. Stat. §53-180.02) (LMC §9.48.040)</p>	<p>Class III Misdemeanor: Up to 3 months in jail and/or \$500 fine. If 18 years of age or younger, 1-12 months' license revocation.</p>
<p align="center">Misrepresenting Age to Purchase Alcohol (Neb. Rev. Stat. §53-180.01) (LMC §9.48.030)</p>	<p>Class III Misdemeanor: Up to 3 months in jail and/or \$500 fine.</p>
<p align="center">Possession of Marijuana (Neb. Rev. Stat §28-416) (LMC §9.48.090)</p>	<ul style="list-style-type: none"> - 1st offense - less than 1 ounce: \$300 fine + drug education course. - 2nd offense - less than one ounce: \$400 fine and up to 5 days in jail. - 3rd offense - less than one ounce: \$500 fine and up to 7 days in jail. - One ounce to one pound: Class III Misdemeanor: Up to 3 months in jail and/or \$500 fine.
<p align="center">Procuring Alcohol for Minor (Neb. Rev. Stat. §53-180)</p>	<p>Class 1 Misdemeanor: Up to 1 year in jail and/or \$1,000 fine.</p>
<p align="center">Theft (Neb. Rev. Stat. §28-510)</p>	<ul style="list-style-type: none"> - Less than \$500 value: Class II Misdemeanor: Up to 6 months in jail and/or \$1,000 fine. - \$500 - \$1,500 value: Class I Misdemeanor: Up to 1 year in jail and/or \$1,000 fine. - \$1,500 - \$5,000 value: Class IV Felony: Up to 2 years' imprisonment, and/or up to \$10,000 fine.
