<p align="center"><b>Contributing to the Delinquency of a Minor</b> (Neb. Rev. Stat. §28-709)</p>	<p>Class 1 Misdemeanor: Up to 1 year in jail and/or \$1,000 fine</p>
<p align="center"><b>Criminal Mischief / Destruction of Property</b> (Neb. Rev. Stat. §28-519)</p>	<ul style="list-style-type: none"> <li>- Less than \$500 damage: Class III Misdemeanor: Up to 3 months in jail and/or \$500 fine.</li> <li>- \$500 - \$1,500 damage: Class II Misdemeanor: Up to 6 months in jail and/or \$1,000 fine.</li> <li>- \$1,500 - \$5,000 damage: Class I Misdemeanor: Up to 1 year in jail and/or \$1,000 fine.</li> </ul>
<p align="center"><b>Disturbing the peace</b> (Neb. Rev. Stat §28-1322) (LMC §9.20.050)</p>	<ul style="list-style-type: none"> <li>- Class III Misdemeanor: Up to 3 months in jail and/or \$500 fine.</li> <li>- LMC: minimum \$150 up to \$500 fine and/or up to 3 months in jail.</li> </ul>
<p align="center"><b>Driving Under the Influence (DUI)</b> (Neb. Rev. Stat. §60-6,196) (LMC §10.16.030)</p>	<p align="center"><b>See DUI Chart</b></p>
<p align="center"><b>Fraudulent / Altered Driver's License</b> (Neb. Rev. Stat. §60-491) (LMC §§9.48.020/9.48.030)</p>	<p>Class III Misdemeanor: Up to 3 months in jail and/or \$500 fine.</p>
<p align="center"><b>Leaving the Scene of a Non-Injury Accident</b> (Neb. Rev. Stat. §60-696)</p>	<p>Class II Misdemeanor: Up to 6 months in jail and/or \$1,000 fine – up to 1 year license revocation.</p>
<p align="center"><b>Maintaining Disorderly House</b> (LMC §9.20.030)</p>	<ul style="list-style-type: none"> <li>- 1<sup>st</sup> offense: \$250 - \$500 fine and/or up to 6 months in jail.</li> <li>- 2<sup>nd</sup> offense: \$350 - \$500 fine and/or up to 6 months in jail.</li> <li>- 3<sup>rd</sup> offense: \$400 - \$500 fine and/or minimum 3 days – up to 6 months in jail.</li> </ul>
<p align="center"><b>Minor in Possession of Alcohol</b> (Neb. Rev. Stat. §53-180.02) (LMC §9.48.040)</p>	<p>Class III Misdemeanor: Up to 3 months in jail and/or \$500 fine. If 18 years of age or younger, 1-12 months' license revocation.</p>
<p align="center"><b>Misrepresenting Age to Purchase Alcohol</b> (Neb. Rev. Stat. §53-180.01) (LMC §9.48.030)</p>	<p>Class III Misdemeanor: Up to 3 months in jail and/or \$500 fine.</p>
<p align="center"><b>Possession of Marijuana</b> (Neb. Rev. Stat §28-416) (LMC §9.48.090)</p>	<ul style="list-style-type: none"> <li>- 1<sup>st</sup> offense - less than 1 ounce: \$300 fine + drug education course.</li> <li>- 2<sup>nd</sup> offense - less than one ounce: \$400 fine and up to 5 days in jail.</li> <li>- 3<sup>rd</sup> offense - less than one ounce: \$500 fine and up to 7 days in jail.</li> <li>- One ounce to one pound: Class III Misdemeanor: Up to 3 months in jail and/or \$500 fine.</li> </ul>
<p align="center"><b>Procuring Alcohol for Minor</b> (Neb. Rev. Stat. §53-180)</p>	<p>Class 1 Misdemeanor: Up to 1 year in jail and/or \$1,000 fine.</p>
<p align="center"><b>Theft</b> (Neb. Rev. Stat. §28-510)</p>	<ul style="list-style-type: none"> <li>- Less than \$500 value: Class II Misdemeanor: Up to 6 months in jail and/or \$1,000 fine.</li> <li>- \$500 - \$1,500 value: Class I Misdemeanor: Up to 1 year in jail and/or \$1,000 fine.</li> <li>- \$1,500 - \$5,000 value: Class IV Felony: Up to 2 years' imprisonment, and/or up to \$10,000 fine.</li> </ul>
